

AUSTRALIAN BULLDOG SOCIETY INC. REQUIREMENTS FOR LITTER REGISTRATIONS

Please read the ABS Inc. Litter Registration Policy given below.

Before your pup certificates can be issued, you need to send to the Registrar ALL of the following:

- a) **ABS Inc. Litter Registration Form**
- b) **Copy of sire/dam pedigree UNLESS they have an ABS Inc. registration no. themselves.**
- c) **Good photograph of sire and dam – UNLESS they have had previously ABS Inc. registered litters. These can be emailed.**
- d) **Good individual photograph of each puppy being registered. These can be emailed.**
- e) **ABS Inc. Stud Certificate (completed & signed by Stud owner)**
- f) **ABS Inc Health Certificate (for sire & dam)**
- g) **Cost per puppy, paid to The Registrar, K Moore (direct deposit, email me for account details, cheque/money order) (do not make out to ABS Inc. please) is \$20.00 per pup certificate HOWEVER this is discounted to \$15.00 per pup certificate IF ALL completed forms and photos are sent to the Registrar on or BEFORE the litter is 9 weeks of age.**
- h) **Please note you have the option to request the Registrar to stamp a particular pup's certificate "NOT FOR BREEDING without prior approval by ABS management committee" – should their be a pup not of appropriate type or health concerns etc.**
- i) **Please note ABS MEMBERSHIP APPLICATIONS FORMS/MONEY to be sent separately to the secretary NOT the registrar.**

The above information should be sent to the Registrar preferably by the time the litter is 6 weeks old, so that certificates can be sent to you to be handed to the pup buyer at time of collection. Remember all pups must be micro chipped and the microchip no. put on the registration form – so at the 6 weeks vacc & vet check would be ideal.

BY 12 WEEKS AFTER LITTER IS WHELPED, the following MUST be sent to the Registrar:

- a) **ABS Inc. Litter Health Form**
- b) **A complete list of pup buyers' names and contact details.**

(If you do not have all the pups sold by 6 weeks of age , you can still send in all the forms listed (a) to (f) above to take advantage of the **DISCOUNTED** price, but be sure to send in the Litter Health Form and complete list of buyers as soon as possible).

(Please note: ABS Members can place 4 pup photos & contact details on www.australianbulldogs.com under Pup Sales section **FOR FREE.**)

Providing ALL of the above information is YOUR responsibility.

Failure to comply with the above, can lead to:

- a) Possible refusal to register any further litters
- b) Possible termination of ABS Inc. membership under Section 9©(iv) “Prejudicial to the ...interests of the association”

Management Committee is sure breeders will understand that it is imperative that registration details be properly completed.

Apply to the Registrar for copies of ABS Inc. forms as needed.

AUSTRALIAN BULLDOG SOCIETY INC. LITTER REGISTRATION POLICY

1. **The ABS Inc will not register litters where the sire/dam have the following relationships:
(a) Father/daughter (b) mother/son (c) brother/sister (d) half brother/half sister (e) grandparent/grandchild.**
2. **The ABS Inc will not register litters where a direct parent (*see note below) is any other breed or where a direct parent* is a straight cross of other breeds (e.g. American Bulldog/British Bulldog or Bullmastiff/British Bulldog etc).**

***NOTE: A ‘direct parent’ is father or mother (sire or dam) NOT grandparent or earlier ancestor.**

For the purposes of generational breeding and restricting the perpetuation of health problems, the ABS Inc wishes to phase out the breeding of 1st generation dogs, therefore FOR ABS INC REGISTRATION:

3. **After 31/10/09 a dog with a British Bulldog or other breed parent (mother/father) cannot be mated to another such dog.
That is:
Only one other breed (**see note below) is allowed to appear on the registration papers as grandparents of any litter.
Other breeds acceptable as great grandparents, great great grandparents and earlier etc.**

And furthermore:

4. **A dog BORN after 31/10/09 which has a British Bulldog or other breed** parent (mother/father) cannot be used for breeding purposes.**

****NOTE: ‘Other breed’ means another breed of dog such as British Bulldog, Bullmastiff, and American Bulldog etc.**
